EXECUTIVE SUMMARY

Mr. Speaker, PFM Acts, 2012 provides the basis at which County budget making process shall be carried out; in these context, the Constitution of Kenya, 2010 Article 220. Section (2) provides that the National legislation shall prescribe;-

- i. The structure of the development plans and budgets of counties, when the plans and budgets of the counties shall be tabled in the county assemblies; and the form and manner of consultation between the national government and county governments in the process of preparing plans and budgets.
- Mr. Speaker, In addition, the County government Act Section 8 (e) provides that, the County Assembly shall approve the County Development Planning. The Public Finance Management Act, Section 126 (1) provides that every County government shall prepare a development plan in accordance with Article 220(2) of the Constitution, which includes;
- a) Strategic priorities for the medium term that reflect the County government's priorities and plans
- b) A description of how the County government is responding to changes in the financial and economic environment.
 - c) Programmes to be delivered with details for each programme of—
 - i. the strategic priorities to which the programme will contribute;
- ii. the services or goods to be provided; measurable indicators of performance where feasible; and iii. the budget allocated to the programme;
- d) payments to be made on behalf of the county government, including details of any grants, benefits and subsidies that are to be paid;
 - e) a description of significant capital developments;
- f) a detailed description of proposals with respect to the development of physical, intellectual, human and other resources of the county, including measurable indicators where those are feasible;
- g) a summary budget in the format required by regulations; and h) Such other matters as may be required by the Constitution or this Act.
- Mr. Speaker, Section 126(2) of Public finance Management Act provides that the County Executive Committee member responsible for finance and planning shall prepare the development plan in accordance with the format prescribed by regulations.

Mr. Speaker, Section 126(3) of the PFM Act, 2012, provides that the County executive Committee Member responsible for planning shall, not later than the 1st September in each year, submit the development plan to the County Assembly for its approval.

However, the 2018/19 ADP was submitted to the County Assembly on 19th April, 2018 in contravention of the provision of the PFM Act, 2012 above.

Mr. Speaker, the County Assembly is an institution entrusted with the responsibility to make legislations for the County Government in accordance with Article 185 of the Constitution. Whereas the constitution provides for consultation and cooperation between the two arms of government in its day to day operations, there is need to respect the constitution and other legislations.

Mr. Speaker, additionally Section 129(5) of the PFM Act, 2012 states that, "the CEC-Finance shall ensure that the budget process is conducted in a manner and within a timeframe sufficient to permit the participants in the process to meet the requirements of the constitution and this Act".

Mr. Speaker, the submission of the ADP to the County Assembly in April has disadvantaged the County Assembly by denying it to have sufficient time as provided in law to interrogate the documents.

ANALYSIS OF THE 2018/19 ANNUAL DEVELOPMENT PLAN (ADP)

I. ADP linkage to CIDP and other plans

Mr. Speaker, Section 108 of the County Government Act requires the County Government to prepare five year County Development plan to set mechanism for preparation of the ADP in accordance with Section 126 of the Public Finance Management Act (PFM), 2012.

The ADP is one year medium term plan which will implement the programmes identified under the Second CIDP 2018- 2022. It also contains specific programmes identified in each sector.

Mr. Speaker, the committee has observed that the ADP has adhered itself to programmes identified in the CIDP in accordance with the requirement of necessary legislations.

II. County Revenues

Mr. Speaker, Isiolo County will get an equitable share of Ksh. 3,925,000,000,conditional allocations of Ksh. 249,049,294 from National Government; conditional allocations of ksh. 382,123,006 from Development partners and target to collect internal county own revenue of ksh. 182,861,343 to fund its budget totaling to ksh. 4,717,572,299.

Mr. Speaker, historical trends in the local revenue generations, since the inception of the County Government, does not support the local revenue target set to be generated by the County Government. These subsequent missed revenue targets, has resulted into spiraling pending bill that has negated the implementations of successive budgets.

The promise of County Target to broaden revenue base, seal revenue leakage and automate revenue collections has not yielded positive impact towards improvement of revenue collections. This is despite huge investments by the County Government towards these initiatives.

Mr. Speaker, this therefore calls for setting of realistic county own revenue target to forestall budget deficits and continued rise of pending bills.

Mr. Speaker, the ADP presented to the County Assembly is a continuation of wish dreams as contained in the County Integrated Development Plan, 2018 - 2022.

The Table 2 above shows that the 2018/19 ADP requires over ksh. 6.3B to be implemented in the 2018/19 financial year. This is against county available development resource of ksh. 1.6B resulting into a deficit of over ksh. 4.7B. (full sector programme is annexed to the report).

Mr. Speaker, the essence of preparing these documents in the budget process is to manage the expectations of the public, link planning to budget and tie resources to programmes as emphasized in the Medium Term Expenditure Framework (M-TEF) and programme Based Budgeting (PBB).

This underscores the need for the ADP to contain realistic programme that can be implemented within the financial year to give it life.

COMMITTEE RECOMMENDATIONS

Mr. Speaker, in view of the above observations, the committee makes the following recommendations on 2018/19 development plan

- 1. The County Executive respects the legal timelines in submission of ADP to give the County Assembly sufficient time as provided in Section 129(5) of the PFM Act, 2012 to interrogate the document adequately.
- 2. That, the Sector Working Groups (SWG's) to always engage with the Sectoral Committees in order to ensure that the plan is done within the set timeline
- 3. That, the County Assembly approves the Annual Development Plan 2018/19 pursuant to the provision Section 126 (3) of the Public Finance Management Act, 2012.
