**COVID-19 MEDICAL EMERGENCY ALLOWANCE AND BENEFITS FOR FRONTLINE
HEALTHCARE WORKERS IN NATIONAL AND COUNTY GOVERNMENTS**

Reference is made to a letter from the Council of Governors Ref. No. COG/6/40 Vol. 53 (40) dated 15th April, 2020 on request for Payment of Allowances to Healthcare Workers in the County Governments. Further reference to a letter from the Ministry of Public Service and Gender Ref. No. MPYG.8/3/1 dated 27th April, 2020) on proposed welfare and insurance package for healthcare workers during the COVID-19 pandemic.

The Salaries and Remuneration Commission deliberated on the matter during its 117th Special Meeting held on 28th April, 2020, in cognizant of the challenges faced by the Healthcare Workers, and approved COVID-19 Medical Emergency Allowance and benefits for the frontline Healthcare Workers as enclosed in **Table 1** estimated to cost **Kshs. 3,013,390,000 billion** as enclosed in **Table 2** for a period of **three (3) months with effect from 1st April, 2020**, subject to availability of funds.

The purpose of this letter therefore, is to present to your office the resultant cost implication of implementing the COVID-19 Medical Emergency Allowance and benefits for frontline healthcare workers in national and county governments for consideration and release of funds by the National Treasury.

The Commission appreciates your continued support as it undertakes its mandate.

BENEFITS FOR COVID-19 BENEFITS FOR FRONTLINE HEALTHCARE WORKERS IN NATIONAL AND COUNTY GOVERNMENTS

(a) Medical Benefits

Medical cover for Healthcare workers to be provided as per existing SRC's Advisory, subject to affordability.

(b) Insurance Cover

Other Insurance benefits under Work Injury Benefits Act (WIBA), Group Personal Accident (GPA) and Group Life Insurance (GLI) to be addressed by the Ministry of Public Service & Gender who will give further guidance in consultation with respective stakeholders as per proposals.

(c) Psychosocial Support

Psychosocial support to Health Workers to be provided for as per existing Public Service Human Resource Manual of 2016, subject to affordability.

(d) Other Welfare Benefits

These to be taken up directly by respective institutions.
